

## Further Resources on Disability Justice for Urban Planners and Designers

Disability Justice for Urban Planners and Designers is a card set meant to guide professionals towards inclusive design, and ultimately, radical access. Prior to creating these cards, we researched the idea of access in a few different spaces- disability justice, urban planning, and design. This document contains the sources used for the cards, in addition to other projects, readings, and podcasts found in the research process. The sources are organized by readings/podcasts and projects, and within these categories, each source is listed in alphabetical order.
